Brief history

- The State Institute of Medicine from Chisinau was founded on October 20, 1945;

1945

- *Nicolae Testemitanu* State Institute of Medicine from Chisinau was reorganized into a university;

1991

- The institute is named after the scientist Nicolae Testemitanu;

1990

1996

- The institution is renamed *Nicolae Testemitanu* State University of Medicine and Pharmacy of the Republic of Moldova

Main challenges

- 1. Insufficient awareness of the accreditation benefits;**
- 2. Costly and laborious (in term of HR, time, monetary, logistic, etc.);**
- 3. Background variation of the accreditation team members;**
- 4. Various perceptions and uneven interpretations of the standards requirements/criteria's;**
- 5. Institutional resistance of the operational staff;**
- 6. Insufficient validation and acknowledgment of the higher authorities;**
- 7. Insufficient vertical and horizontal communication at various level.**

Lessons learned

- 1. Earlier start – better outcomes! (pioneering)**
- 2. Fear of the comfort zone shall NOT be underestimated**
- 3. Capacity building and development of accreditation teams**
- 4. Exposure and employments opportunities for the created accreditation experts/teams**
- 5. Organisational discipline is mandatory!**
- 6. Increased awareness of the benefits**
- 7. The appropriate motivation of the involved teams is of crucial importance**
